WE DEFEND MORE THAN 2,500 PARENTS ANNUALLY AND HAVE DEFENDED NEARLY 12,000 PARENTS SINCE 2007 AGAINST CHARGES OF NEGLECT OR ABUSE IN MANHATTAN AND QUEENS FAMILY COURTS.
