WE DEFEND MORE THAN 2300 PARENTS ANNUALLY AND HAVE DEFENDED NEARLY 14,000 PARENTS SINCE 2007 AGAINST CHARGES OF NEGLECT OR ABUSE IN MANHATTAN, QUEENS, AND BRONX FAMILY COURTS.
